

Terms and Conditions

1. Introduction

Welcome to Unnecessarily (“Website”). By accessing or using our Website, you agree to comply with and be bound by these Terms and Conditions. If you do not agree with these terms, please do not use our Website.

Before continuing, please review the following items, which are pertinent to these terms.
